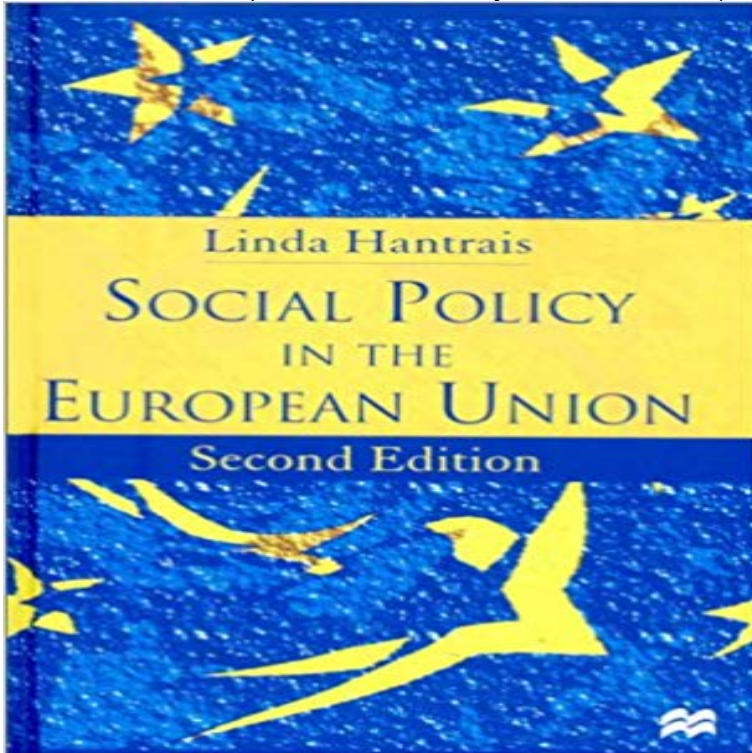


Social Policy in the European Union, Second Edition
