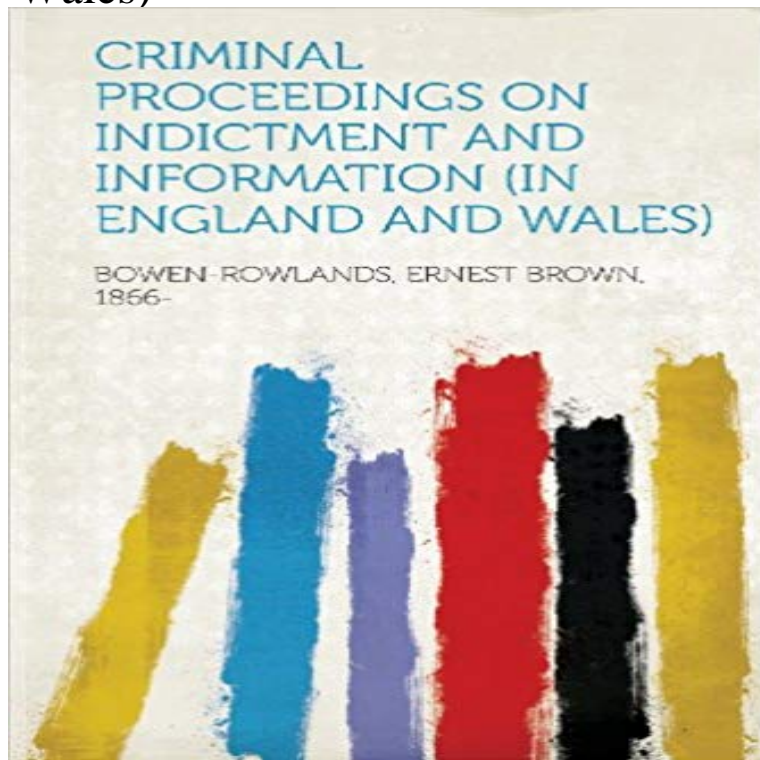


Criminal Proceedings on Indictment and Information (in England and Wales)
