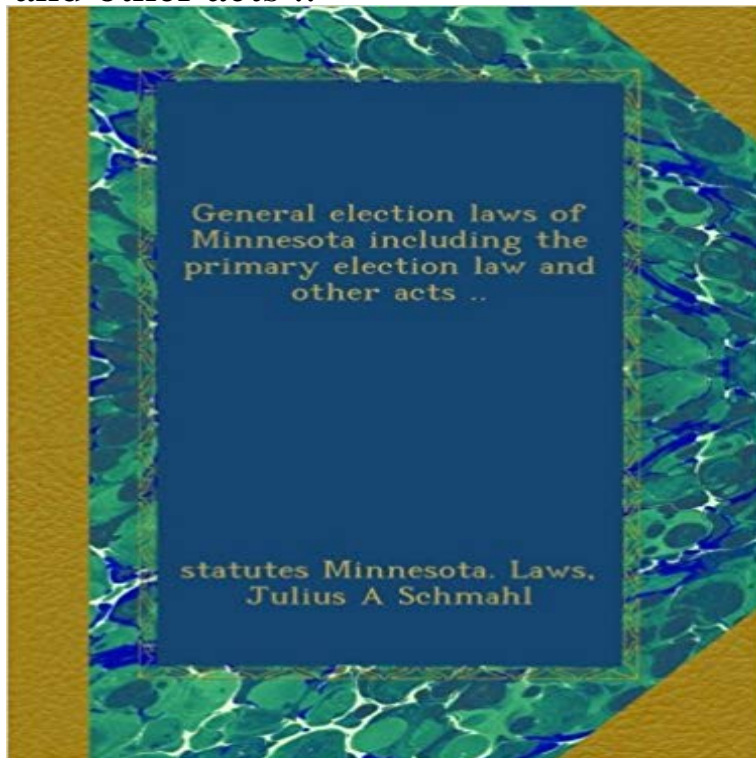


## General election laws of Minnesota including the primary election law and other acts ..
