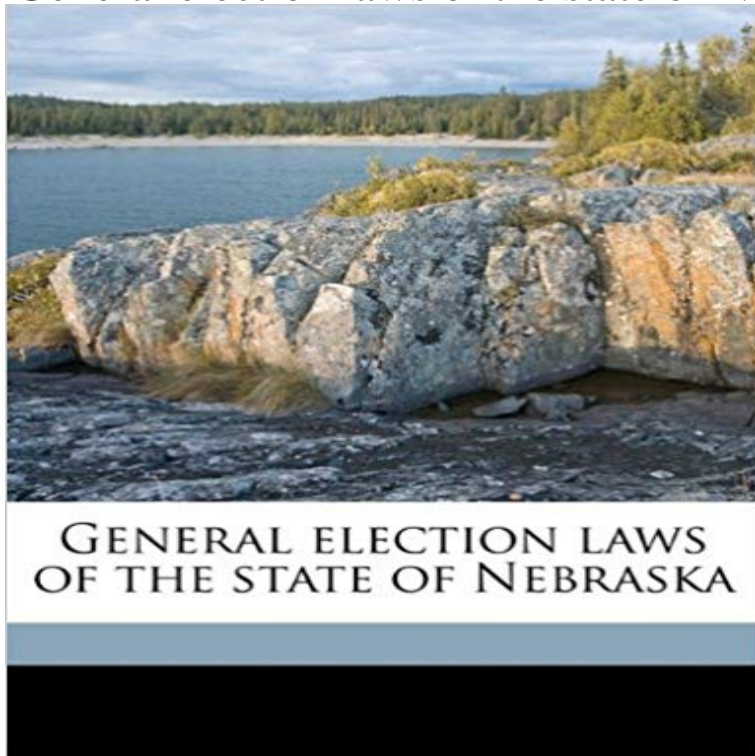


General election laws of the state of Nebraska
