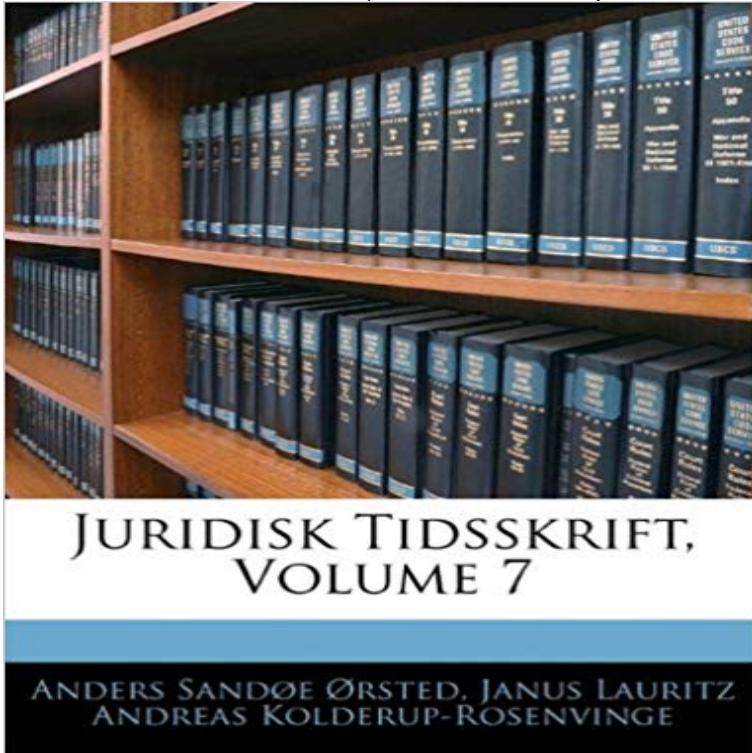


Juridisk Tidsskrift, Volume 7 (Danish Edition)
