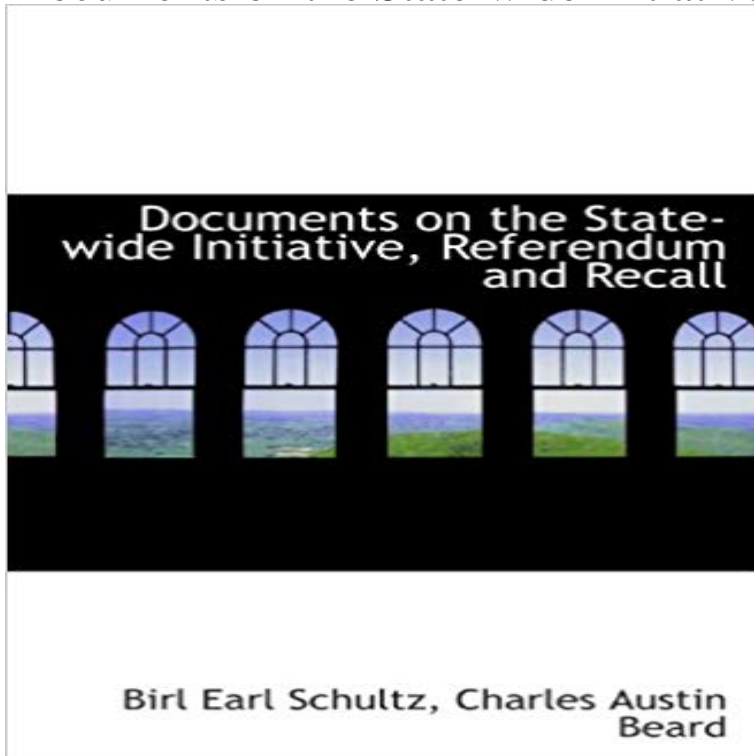


Documents on the State-wide Initiative, Referendum and Recall
