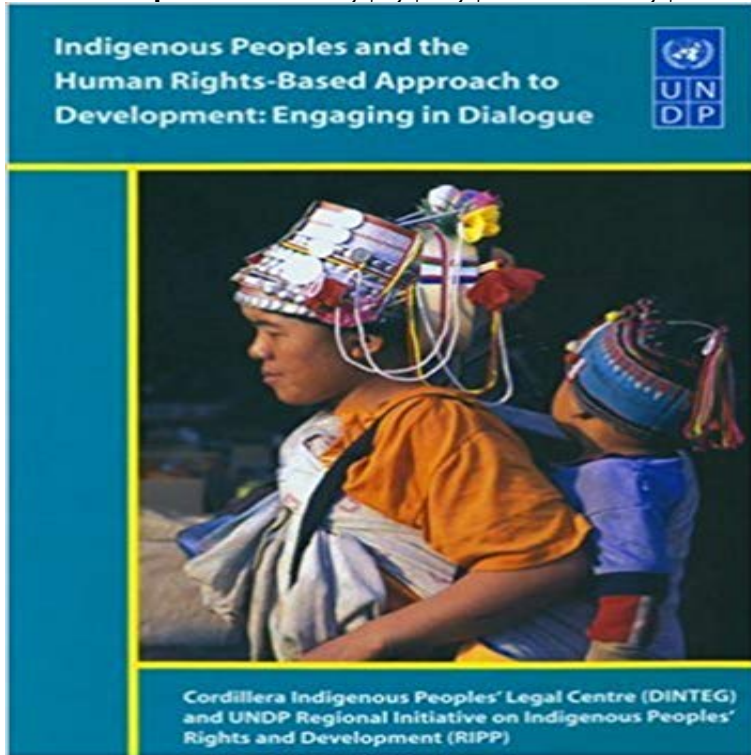


Indigenous Peoples and the Human Rights-based Approach to Development: Engaging in Dialogue
