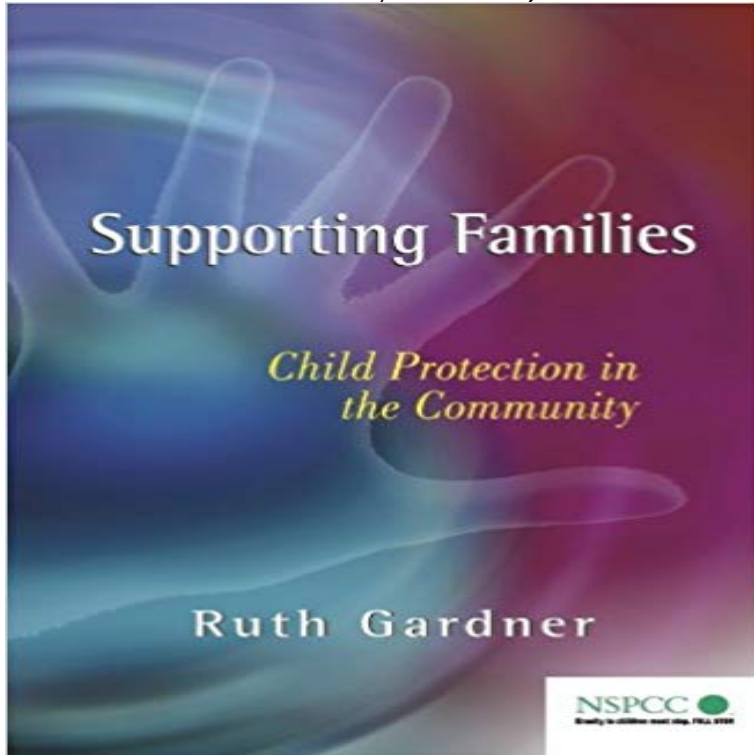


Supporting Families: Child Protection in the Community (Wiley Child Protection & Policy Series)
